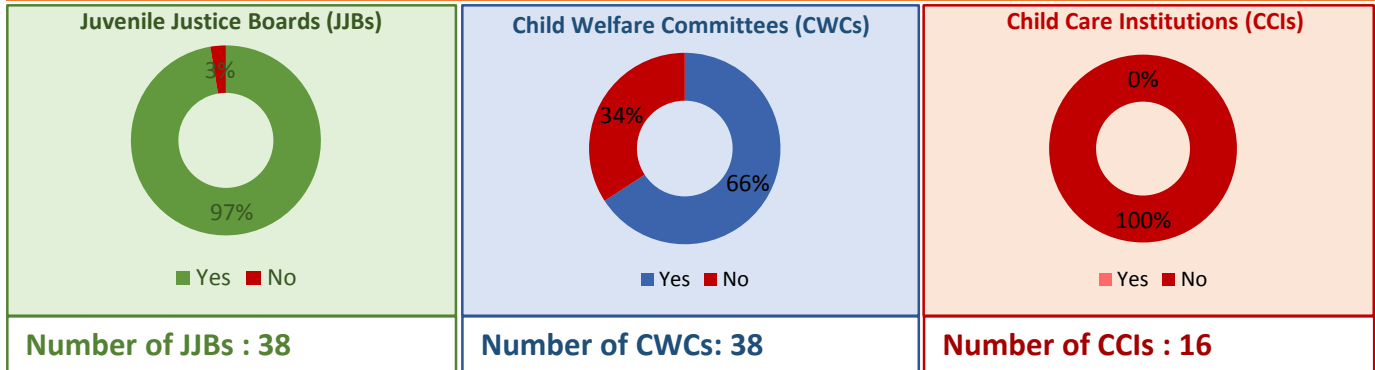

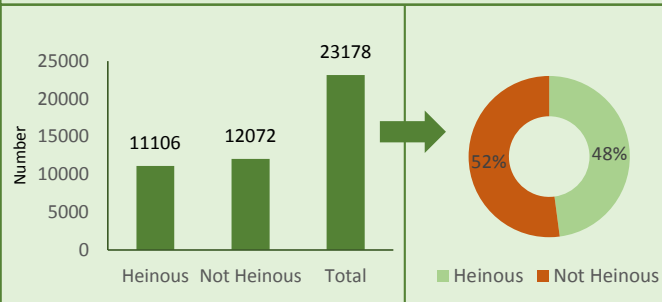

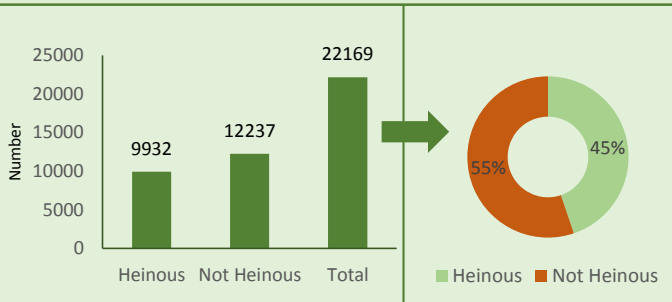

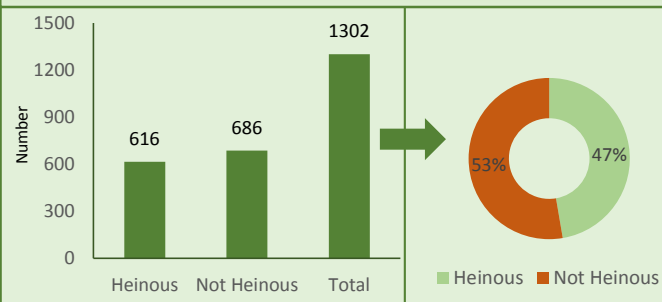
Cases pending with JJBs according to nature of the offence



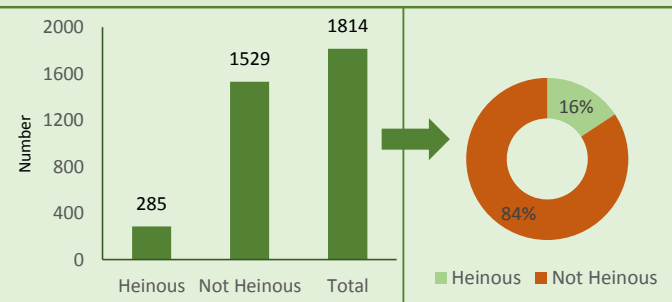
Old cases pending with JJBs according to nature of the offence



New cases pending with JJBs according to nature of the offence

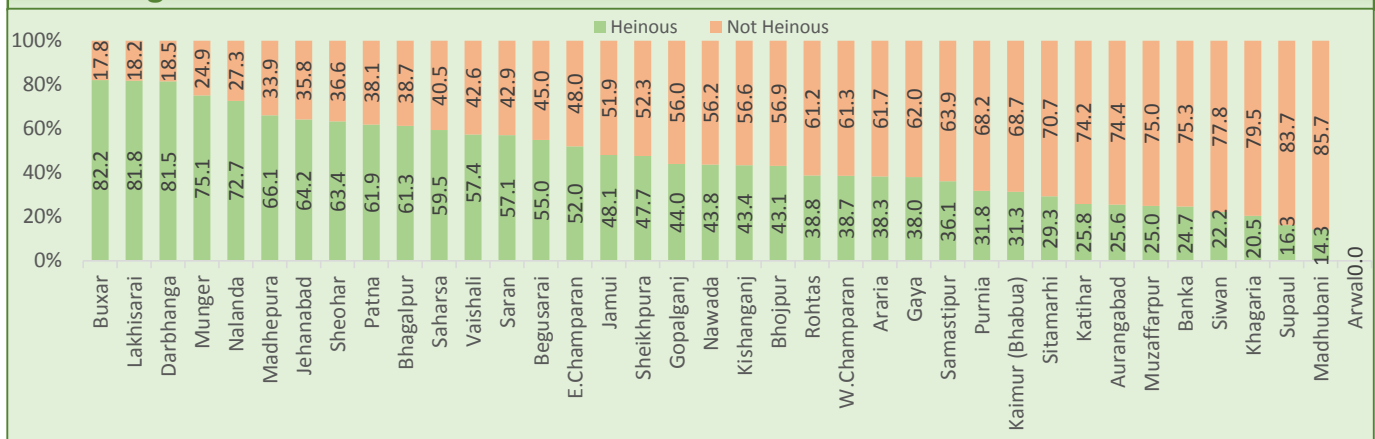


Cases disposed by JJBs according to nature of the offence



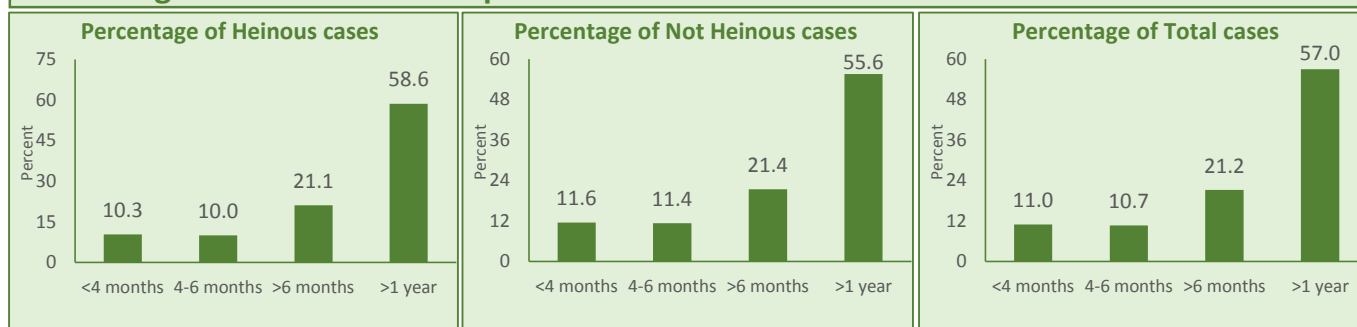
Percentage distribution of Heinous and Not Heinous cases in all JJBs of Bihar

October - December 2014

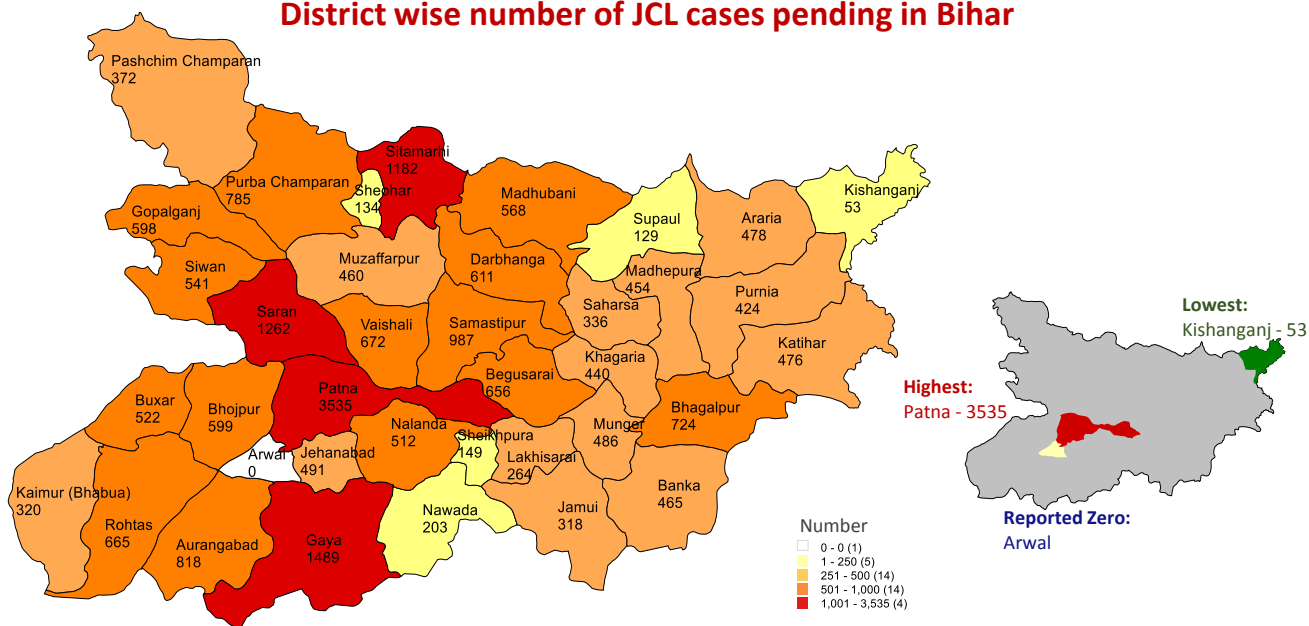


Percentage Distribution of the Cases Pending in Juvenile Justice Board according to nature of cases & period of duration

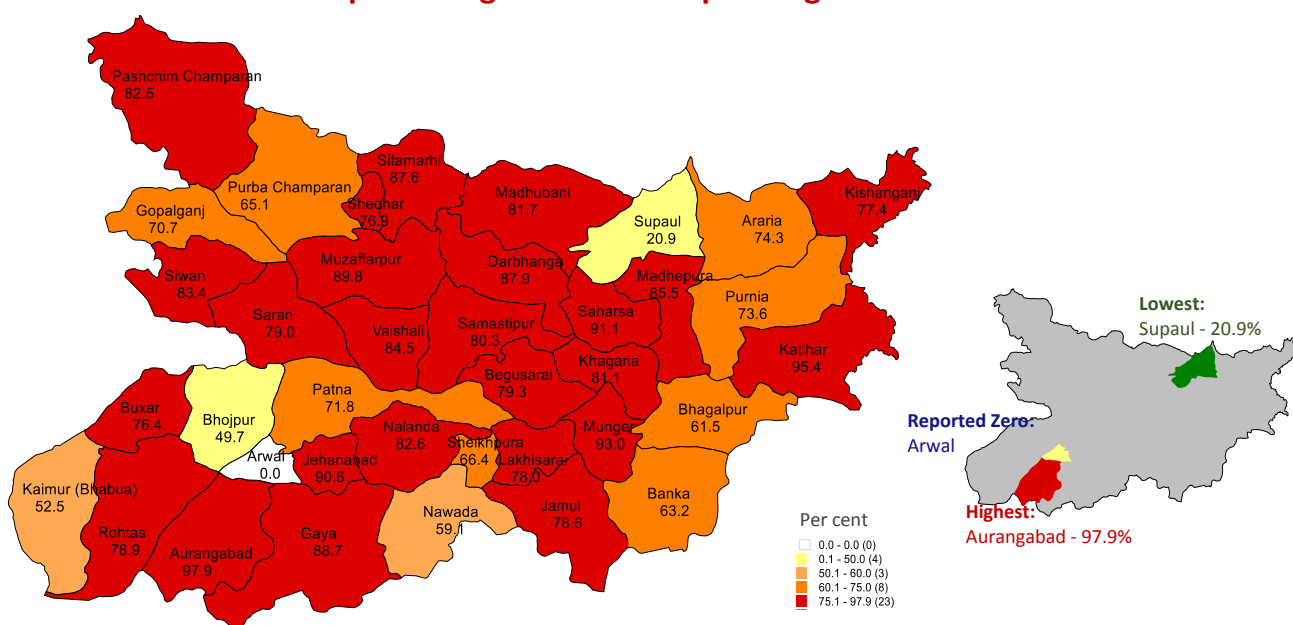


District wise number of JCL cases pending in Bihar

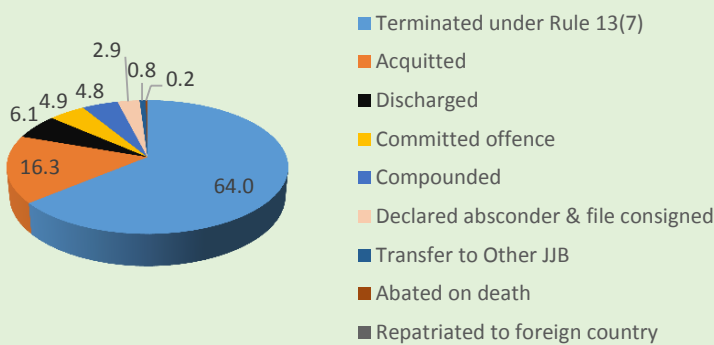
District wise percentage of JCL cases pending more than 6 months

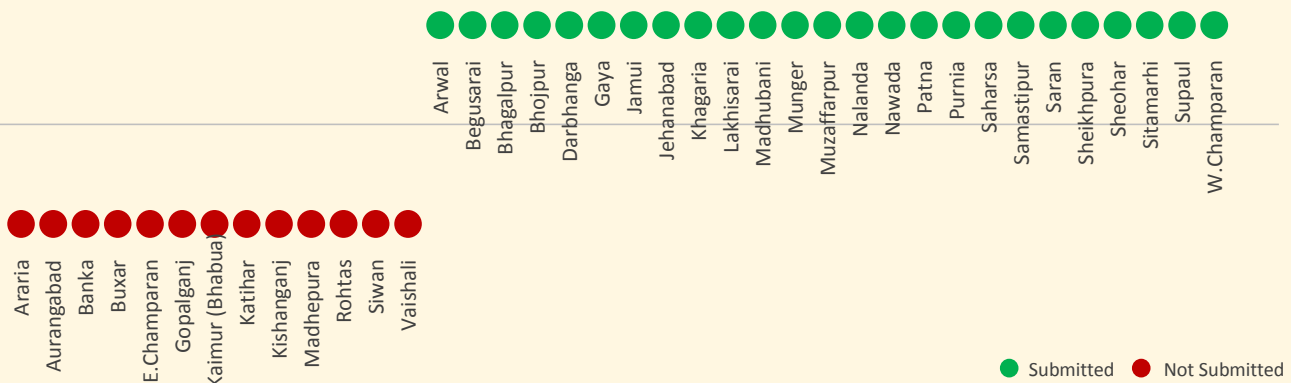

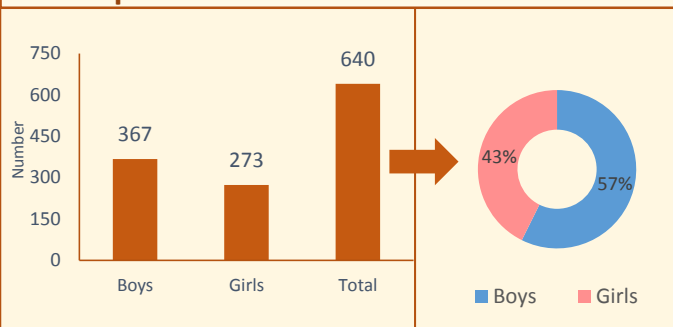

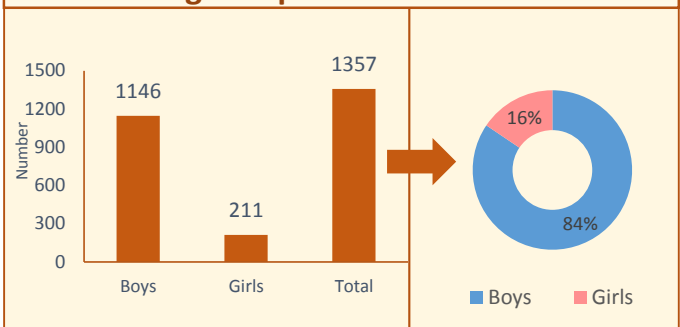
Details of CNCP (Children in Need of Care & Protection) cases pending in CWCs

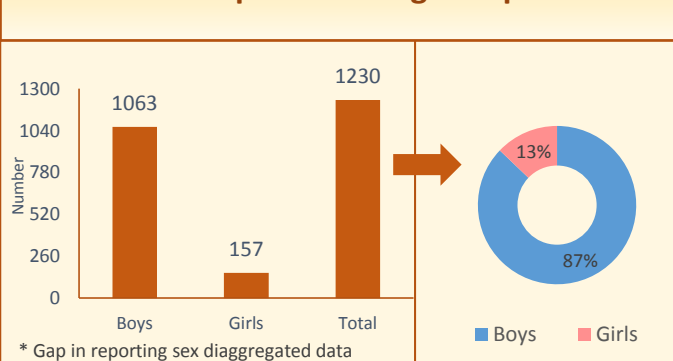
CNCP cases before the CWCs on the first day of the quarter



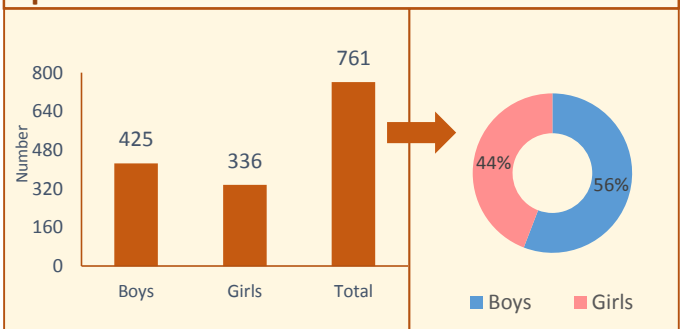
Fresh/new CNCP cases brought before the CWCs during the quarter



CNCP cases disposed during the quarter

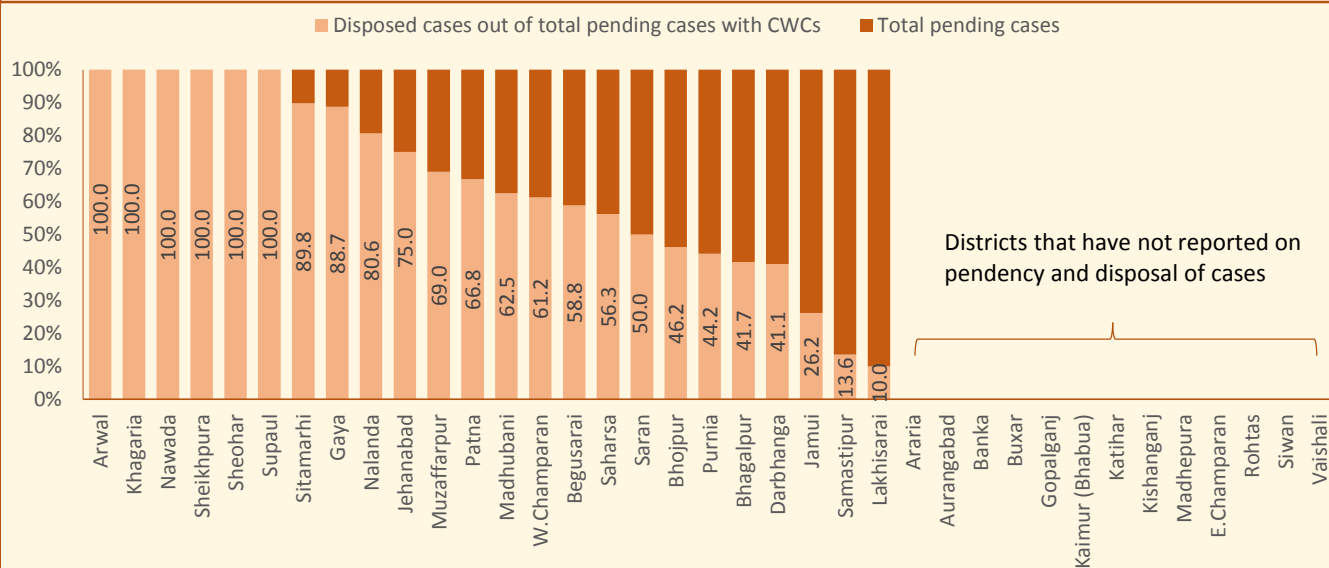


CNCP cases pending on the last day of the quarter



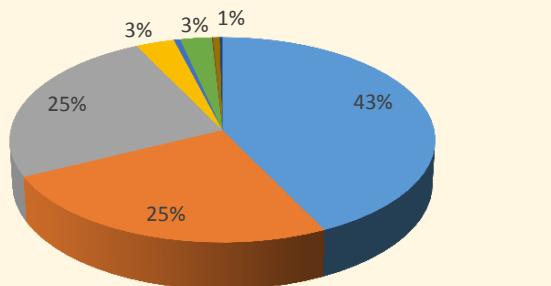
Disposed cases as % of total CNCP cases with the CWC during the quarter

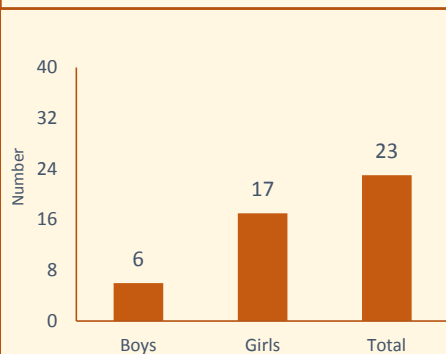

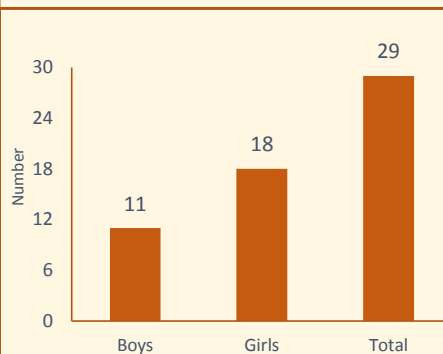
